SUMMARY ANNUAL REPORT

FOR SANTA MONICA POLICE OFFICERS' ASSOCIATION REIMBURSEMENT TRUST

This is a summary of the annual report of the Santa Monica Police Officers' Association Reimbursement Trust, E.I.N. 95-7011261, Plan No. 501, for the year ended December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$25,528,849 as of December 31, 2023, compared to \$22,679,913 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$2,848,936. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4,191,142 including employer contributions of \$362,805, participant contributions of \$652,824 and gain from investments of \$3,175,513.

Plan expenses were \$1,342,206. These expenses included \$247,910 in administrative expenses and \$1,094,296 in benefits paid to participants and beneficiaries.
